2. Unless otherwise stated, the contents of this affidavit are facts that are either within my personal knowledge or based on information provided to me by my lawyer ("**Counsel**") which I believe to be true.
3. At the hearing of this application, Counsel shall seek leave of this Honourable Court to refer to all the processes filed in this matter as if same were part of the instant application.
4. Unless expressly stated, I deny each and every deposition in the affidavit in support of the of the contempt application filed on 14<sup>th</sup> December 2023 (the "**Contempt Application**").
5. As an officer of the Court, I will not deliberately do anything that will bring the administration of justice into disrepute. And, if my actions in this matter have in any way given that impression, I sincerely apologise to this Honourable Court.

9. Further, I had no knowledge of the pending application for injunction when I acted on the Company's resolution to appoint Ferociter Nominee Services Limited as the Company secretary.
10. I deny paragraphs 13 and 14 of the affidavit in support of the Contempt Application and state that the Contempt Application lacks any legal merit. Therefore, I pray that this Honourable Court dismiss it with punitive costs.
